

# The Hobby Heat Promotion (EU & UK)

## OFFICIAL RULES

Sponsored by Whatnot Europe Limited ("Sponsor" or "Whatnot")

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED.** BY ENTERING OR PARTICIPATING IN THE PROMOTION, YOU AGREE TO THESE "OFFICIAL RULES," WHICH ARE A CONTRACT, SO READ THEM CAREFULLY BEFORE PARTICIPATING.

## 1. PROMOTION PERIOD

The Hobby Heat Promotion (the "Promotion") begins on February 28, 2026 at 12:00:01 AM UTC and ends on March 1, 2026 at 11:59:59 PM UTC (the "Promotion Period"). Sponsor's clock will be the official timekeeper for the Promotion.

## 2. ELIGIBILITY

Open only to legal residents of the United Kingdom, Germany, France, the Netherlands, Belgium, Ireland, and Austria, who are eighteen (18) years of age or older at the time of entry and have a valid Whatnot account with a rating of 4.5 or greater. Employees, officers, and directors of Whatnot Europe Limited and its affiliates, subsidiaries, advertising and promotion agencies, and immediate family members or persons living in the same household are not eligible. Void where prohibited.

## 3. HOW TO ENTER

You may enter the Promotion in one of the following two ways:

- a. Receive one (1) entry for each non-canceled sale made during a show scheduled in the Sports Card category between February 28, 2026-March 1, 2026 that uses the tag "Hobby Heat" during the Promotion Period. Shows must be scheduled during the Promotion Period and use the required tag to be eligible. Mystery games, wheels, and similar chance-based selling formats are not permitted as part of qualifying shows for this Promotion. Sales from such formats will not count toward entries. Sales that are canceled, refunded, or charged back during or after the Promotion Period will not count toward entries and any entries attributed to such sales may be removed
  
- b. Receive one (1) entry by scheduling at least one show in the Sports Card category during the Promotion Period using the tag "Hobby Heat." You must have a Whatnot seller account and schedule at least one qualifying show tagged "Hobby Heat" during the Promotion Period. No sales are required for this entry method.

Use of multiple accounts, identities, or devices to circumvent these rules will result in disqualification. Automated entries, bulk entries, or entries submitted by third parties will be disqualified. All entries, regardless of method, have an equal chance of winning and will be pooled together for the drawing.

## 4. PRIZE

One (1) winner will receive a \$3,000 cash prize. Prize is not transferable and may not be substituted. Approximate Retail Value ("ARV"): \$3,000. All prize details are at the Sponsor's sole discretion. The winner will be required to complete a declaration of eligibility, liability/publicity release, and may be required to complete tax documentation as required by applicable law.

## 5. WINNER SELECTION & NOTIFICATION

Winner will be selected in a random drawing from all eligible entries received. Odds of winning depend on the number of eligible entries received. Winner will be notified by email within five (5) business days after the end of the Promotion Period and must respond within five (5) days or prize may be forfeited and awarded to an alternate.
