

# Whatnot Toy World Seller Promotion

## OFFICIAL RULES

Sponsored by Whatnot Inc. ("Sponsor" or "Whatnot")

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED.** BY ENTERING OR PARTICIPATING IN THE PROMOTION, YOU AGREE TO THESE "OFFICIAL RULES," WHICH ARE A CONTRACT, SO READ THEM CAREFULLY BEFORE PARTICIPATING.

## 1. PROMOTION PERIOD

The Whatnot Toy World Seller Promotion (the "Promotion") begins on March 20, 2027 at 12:00:01 AM Eastern Time and ends on March 22, 2026 at 11:59:59 PM Eastern Time (the "Promotion Period"). Sponsor's clock will be the official timekeeper for the Promotion.

## 2. ELIGIBILITY

Open only to legal residents of the United States and Canada, who are eighteen (18) years of age or older at the time of entry and have a valid Whatnot account with a rating of 4.5 or greater. Employees, officers, and directors of Whatnot Inc. and its affiliates, subsidiaries, advertising and promotion agencies, and immediate family members or persons living in the same household are not eligible. Void where prohibited.

## 3. HOW TO ENTER

You may enter the Promotion in one of the following two ways:

- a.** Receive one (1) entry for every \$1,000 in GMV during a show scheduled between March 20, 2026 and March 22, 2026 that uses the tag "Whatnot Toy World" during the Promotion Period. For purposes of this Promotion, "GMV" means the total value of non-cancelled orders processed on the Whatnot Platform in the Toy categories during the Promotion Period. Shows must be scheduled during the Promotion Period, use the required tag, and be in the Toy categories to be eligible. Mystery games, wheels, and similar chance-based selling formats are not permitted as part of qualifying shows for this Promotion. Sales from such formats will not count toward entries.
- b.** Receive one (1) entry by scheduling at least one show in the Toys category during the Promotion Period using the tag "Whatnot Toy World." You must have a Whatnot seller account and schedule at least one qualifying show tagged "Whatnot Toy World" during the Promotion Period. Scheduled shows must not be canceled prior to their scheduled start time to qualify. No sales are required for this entry method.

Use of multiple accounts, identities, or devices to circumvent these rules will result in disqualification. Automated entries, bulk entries, or entries submitted by third parties will be disqualified. All entries, regardless of method, have an equal chance of winning and will be pooled together for the drawing.

## 4. PRIZE

One (1) winner will receive a \$10,000 cash prize. Prize is not transferable and may not be substituted. Approximate Retail Value ("ARV"): \$10,000. All prize details are at the Sponsor's sole discretion. The winner will be required to complete an affidavit of eligibility, liability/publicity release, and IRS Form W-9 or W-8BEN as a condition of receiving the prize.

## 5. WINNER SELECTION & NOTIFICATION

Winner will be selected in a random drawing from all eligible entries received. Odds of winning depend on the number of eligible entries received. Winner will be notified by email within five (5) business days after the end of the Promotion Period and must respond within five (5) days or prize may be forfeited and awarded to an alternate. By entering, entrants agree to be bound by these Official Rules and the decisions of Sponsor, which are final. Sponsor reserves the right to disqualify any entrant who tampers with the entry process, circumvents entry limits, provides false information, or otherwise violates these rules. Sponsor is not responsible for lost, late, incomplete, or misdirected entries; technical, hardware, or software malfunctions; lost or unavailable network connections; or failed, incorrect, inaccurate, incomplete, garbled, or delayed electronic communications. Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify, or suspend the Promotion if it becomes incapable of running as planned for any reason, including but not limited to fraud, technical failures, or any other causes beyond Sponsor's control. In the event of termination, winners will be selected from among all eligible entries received as of date of termination.
