

Whatnot Toy World Buyer Promotion

OFFICIAL RULES

Sponsored by Whatnot Inc. ("Sponsor" or "Whatnot")

1. SWEEPSTAKES PERIOD

The Whatnot Toy World Promotion (the "Sweepstakes") begins on March 20, 2026 at 12:00:01 Eastern Time and ends on March 22, 2026 11:59:59 PM Eastern Time (the "Sweepstakes Period"). Sponsor's clock will be the official timekeeper for the Sweepstakes.

2. ELIGIBILITY

Open only to legal residents of the United States and Canada (excluding Quebec), who are eighteen (18) years of age or older at the time of entry and have a valid Whatnot account with a rating of 4.5 or greater. Employees, officers, and directors of Whatnot Inc. and its affiliates, subsidiaries, advertising and promotion agencies, and immediate family members or persons living in the same household are not eligible. Void where prohibited.

3. HOW TO ENTER

You may enter the Sweepstakes in one of the following two ways:

a. Eligible Purchases: Make any purchase during a live show tagged "Whatnot Toy World" in the Toys category

b. Alternate Method of Entry (AMOE): Enter your name, email address, mailing address, phone number, and Whatnot account name via the following [Google Form](#) during the Sweepstakes Period. All required information must be provided and you must have a Whatnot account to enter and win.

Entry Limitations

One (1) entry per person during the Sweepstakes Period. All entries, regardless of method, have an equal chance of winning and will be pooled together for the drawing.

Purchase Entries: Purchases must be completed during shows tagged "Whatnot Toy World" in the Toys category. Refunded or cancelled purchases void corresponding entries.

AMOE entries: Automated entries, bulk entries, or entries submitted by third parties will be disqualified. **If Sponsor determines, in its sole discretion, that any entrant has initiated automated entries, bulk entries, or entries submitted by third parties, all of that entrant's entries will be disqualified.**

4. PRIZE

Two (2) winners will receive \$5,000 of Whatnot promotional credit, redeemable for purchases on the Whatnot platform. Prize is not transferable and may not be substituted.
